Upon consideration of appellants' emergency motion for expedited briefing, argument, and decision, and for a decision by the close of business on Thursday, October 9, 2008, and appellees' opposition thereto,

### **IT IS ORDERED:**

1. The emergency motion is **GRANTED**.
2. Appellants shall file by 9:30 a.m. on Monday, October 6, 2008, the original and six copies of both (1) an unbound but otherwise rule-compliant brief no more than thirty pages in length and (2) an unbound but indexed and tabbed set of the relevant documents from the superior court proceedings, including the pleadings, the motions at issue, and the superior court's decision. Material not submitted for the superior court's consideration may not be included. Appellants shall hand-serve counsel for appellees a copy of appellants' filing by 10:00 a.m. that day.



3. Appellees shall file by 4:30 p.m. on Tuesday, October 7, 2008, an original and six copies of an unbound but otherwise rule-compliant brief no more than thirty pages in length, and, if necessary, an indexed and tabbed set of any relevant documents from the superior court proceedings not submitted by appellants. Material not submitted for the superior court's consideration may not be included. Appellees shall hand-serve counsel for appellants with appellees' filing by 5:00 p.m. that day.

4. Oral arguments are set for Wednesday, October 8, 2008, at 3:00 p.m. in the supreme court courtroom in the Boney Courthouse, Anchorage, Alaska. Each side shall have thirty minutes for argument.
